Our right to bear arms is
affirmed in the
Second Amendment.

2.

The right to bear arms is
an **“individual”** right,
not an elusive
“collective” right.

3.

James Madison, (the author of the Second Amendment,) made it clear in the Federalist Papers, that he meant for the right to bear arms to be an individual right.

4.

The term: “The People”, in the Second Amendment, refers to an individual’s right **every** time it is used in the Bill of Rights, including the First, Second, Fourth, Ninth, & Tenth Amendments.

5.

The term: “Militia” in the Second Amendment **also** refers to all individual citizens of adult status.

6.

The same Congress that enacted the Bill of Rights enacted the Militia Act of 1792, which states that the **“militia”** shall be defined as **“all able bodied male adults.”**

7.

The U.S. Code, Title 10, Section 31, also states that the term “militia” refers to all able bodied males.

8.

The term “militia” in the Second Amendment does not refer to the National Guard, as the National Guard began 117 years after the Second Amendment was written.

9.

Until the twentieth century, every free adult male was **required** to own a firearm.

10.

The Bill of Rights does
not grant or bestow
rights – it merely
affirms them.

11.

If the Founding Fathers truly believed only a separate military body should bear arms, why did they themselves and the other citizens of that period bear arms?

12.

The Founding Fathers
refused to ratify a
Constitution that did **not**
protect our individual
liberties.

13.

It was the inclusion of the Second Amendment that made all Americans truly equal – that is, the right to self protection is not limited to an elite few: the aristocracy and government officials, but to all men.

14.

The Second Amendment was also based partly on the State Constitutions of the first colonies, each of which also affirmed our right to bear arms.

15.

Gun Control
is not about guns
– it's about control.

16.

The primary purpose of owning a handgun is **not** to kill, but to preserve and protect the life of its owner.

17.

It is only the **misuse**
of guns that is wrong,
and anything can
be misused.

18.

Gun owners are actually
much safer than
car owners.

19.

We do not ban
cars because of
traffic deaths.

20.

We do not ban
matches because of
fire related deaths.

21.

Even “*Mothers Against Drunk Driving*” have the sense to go after the drunk driver, and not the vehicle.

22.

Our focus should be on
crime and criminals,
not on guns.

23.

A ban on private gun ownership would make crime easier and safer for criminals.

24.

If all guns suddenly disappeared from the world, crime would actually escalate.

25.

Without guns,
individuals would live
at the mercy of
gangs and mobs.

26.

Even if guns really were
evil, they would be a
necessary evil in
a real world.

27.

It is a natural law of
instinct to defend
oneself from danger.

28.

If animals and insects
are equipped to defend
themselves, why
shouldn't we be?

29.

Criminals don't get their
guns from legal sources.

30.

The majority of
Americans don't want a
ban on guns.

31.

The vast majority of
Peace Officers are
against a gun ban.

32.

An alarm cannot protect
you from a
determined assailant.

33.

Martial Arts training
won't protect you from
an armed assailant.

34.

Mace, stun guns, and
tasers are not enough to
protect you from an
armed attacker.

35.

Passive behavior will
certainly not protect you
from an assailant.

36.

A gun ban will neither
curb nor stop
crimes of passion.

37.

On the other hand, proper use
of firearms can most certainly
stop a crime of passion
in its tracks.

38.

A gun ban will not
prevent suicides.

39.

Citizens should have the
ability to be armed in
case of **riots**.

40.

Citizens should have
the ability to be armed
in case of
rampage killings.

41.

Citizens should have
the ability to be
armed in case of
terrorist attacks.

42.

Citizens should have the
ability to be armed in
case of **invasion.**

43.

Citizens should have
the right to be armed
in case of **tyranny**.

44.

The sport of football
has been more lethal
to children than
guns have been.

45.

Regular household items
have been more
lethal to children
than guns.

46.

Toys are more lethal
to kids than guns.

47.

Banning cheaper types
of handguns
victimizes the poor.

48.

Many gun ban advocates
purposefully distort
the facts.

49.

Liberal news reporters
tend to skew the news in
favor of a gun ban.

50.

Many politicians and celebrities who are outspoken on behalf of a gun ban tend to embrace guns when their own lives are in danger.

51.

Proponents of gun bans totally ignore the many uses of guns in a rural way of life.

52.

Most violent crimes do
not involve guns.

53.

Effective training in gun
use truly equalizes a
woman to her
male assailant.

54.

Most gun crime victims
are hard drug users
and are
criminals themselves.

55.

Guns in the hands of law
abiding citizens have saved
far more lives than have been
lost in accidental shootings.

56.

There are fewer accidental gun deaths than almost any other classification of accidental death.

57.

The fact that accidental deaths are news worthy proves their rarity.

58.

The citizen to Peace Officer ratio is far too great for the police to effectively protect each citizen.

59.

At times, law
enforcement **refuses**
to come to the aid
of a citizen.

60.

Even our laws state that the police do not have a responsibility to protect every citizen, but simply the “citizenry at large.”

61.

The police usually arrive
too late to prevent
a crime.

62.

After seeing so much police brutality and corruption, are you certain you want to trust them with your safety and the safety of your home and family?

Areas with gun bans
have the worst crime.

64.

Areas that have highest
gun ownership have the
least crime.

65.

A gun is an excellent
“defensive” weapon.

66.

The simple fact that you
might be armed can
give pause to a
would be assailant.

Criminals are already
less likely to attack
someone who may
be armed.

68.

An unarmed citizen is
the criminal's victim
of choice.

69.

A gun ban is just
another “feel good”
approach to problems.

70.

Education will save
lives; a gun ban will not.

71.

Actual enforcement of
the existing laws would
be far more effective
than banning guns.

72.

Keeping criminals
locked up would be far
more effective than
banning guns.

73.

Plato knew a citizenry
must be disarmed to
be controlled.

74.

Aristotle was against
government enforced
disarmament.

75.

Even Christ Himself
instructed His disciples
to arm themselves.

76.

Hitler disarmed the Jews
before he began
exterminating them.

77.

Oskar Schindler armed his Jew workers at the end of the war in case they had to fight.

78.

There are many, many,
examples of disastrous
disarmaments
throughout history.

79.

A ban on guns would be
no more effective than
Prohibition was from
1920 to 1933.

80.

A ban on guns would
be no more effective
than our war on
drugs has been.

81.

The advent of the
gun provided
individual liberty.

82.

The founding fathers did not conjure up the right to bear arms out of thin air – they had studied history and learned its lessons.

Gun control is really
about “citizen” control.

We must stand against
power abuses of
the government.

85.

Those without the right
to be armed are not free.

86.

Being armed enables our
citizenry to enforce its
other freedoms.

Gun bans have not only failed to bring crime down, but crime has actually escalated in countries that have instituted gun bans.

you're unarmed?

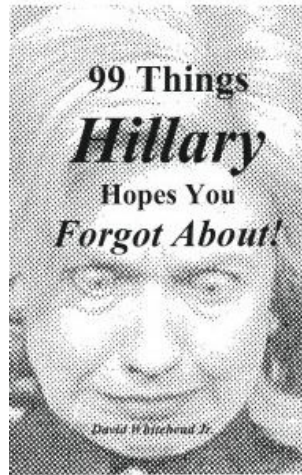
